A nurse or representative of St. Luke Home Health Care, Inc. receives the referral information. The patient is signed up for the various services in accordance with the physician's order/s. A licensed professional from St. Luke Home Health Care, Inc. will be sent to conduct an initial evaluation of the patient within 24 to 48 hours unless specific care is required on the same day of the referral.
